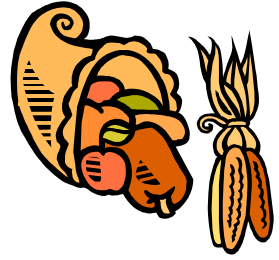




# FCBA Young Lawyers 2011 Thanksgiving Basket Drive
