#### Where did you grow up?

I grew up in Hodgenville, Ky in the Heartland of the State. I attended high school at LaRue County High School. I was raised by an amazing single mother, Linda. She instilled in me the value of hard work, dedication, and perseverance. After graduating as Valedictorian of my class, I attended Hanover College as a Horner Scholar.

#### Why law school?

As one of the first members of my family to attend college, I developed a relationship, through various community and school activities, with Honorable Judge James E. Bondurant, the local District Judge, gentleman lawyer, and farmer. With the assistance of Judge Bondurant and Hon. Don Cetrulo, then AOC director, I was hired as one of the first college law clerks in Kentucky during the summers of 1993 and 1994. During those two summers, I worked for Judge Bondurant, as well as the District Judges in Nelson, Warren, and Jefferson Counties. Judge Bondurant helped my mother, sister and myself change our last name to Boyd, my mother's maiden name after I reached the age of majority. The invaluable experience, education, and encouragement I received during this time, motivated me to pursue a career in the practice of law. I owe Judge Bondurant a great debt of gratitude for all he did for me.

#### Who is "we"?

I am the proud and loving father to two children, Elijah James (16) and Katherine Ann (13). They are my world and motivation to be the best father and person that I can be. Eli is a member of the Frederick Douglass Golf team and I serve as the President of the FDHS Golf Boosters. Katie is a member of the EJ Hayes XC team as well and will serve as a WEB leader during her last year of middle school.



## What has been the best and hardest part of practicing law for you?

The best part is an easy answer: Helping people. In criminal law, the satisfaction of successfully defending a client against false charges or seeing a person find a road to a better more productive life is a major motivator for me.

As far as the hardest part, my answer has changed over the past several months, as we have seen our world and the court system turned upside down as we deal with the present reality. It has been quite difficult to not be able to see my clients and colleagues in person. Although, Zoom Court has its upsides, mainly being able to "go to court" from my kitchen table wearing a jacket and tie on top and gym shorts on the bottom.

#### What are your goals for the Fayette County Bar Association for the upcoming year?

We are living in a time of uncertainty and change; the time is right for us as an organization to stand even taller on the side of equal justice for all. I hope to create opportunities for members of the Bar Association to participate in positive change in the justice system and our community. As a first step in this goal, we will collaborate with the National Bar Association, John Rowe Chapter to put on a series of webinars to provide a forum to listen and learn as we all grow in understanding of the plight of all members of society.





We are living in unprecedented times as the COVID-19 pandemic continues to wreak havoc on our health, safety, and the economy as over 15,000 Kentuckians have now been infected. This virus is changing everything about our daily lives in the process. Therefore, we need to have an unprecedented response. The

economic impact of this virus spreads far beyond those infected and will mean that even more Kentuckians will be living in poverty and in need of legal services that they cannot afford. Even before this outbreak, Civil Legal Aid programs throughout the country have been turning away approximately half of all eligible applicants that seek their assistance due to limited staffing. Moving forward, the need for volunteer attorneys will be greater than ever to ensure that our fellow Kentuckians are getting the legal assistance that they desperately need and deserve.

Kentucky's legal aid programs have launched Together Lawyers Can to address this anticipated rise in numbers and the need for civil legal aid. Together Lawyers Can is a collaboration of the Kentucky Access to Justice Commission, Appalachian Research and Defense Fund, Kentucky Equal Justice Center, Kentucky Legal Aid, Legal Aid of the Bluegrass, and the Legal Aid Society. It is a virtual CLE series designed to recruit and train volunteer attorneys to assist Kentuckians in the areas of law most impacted by the COVID-19 pandemic. Lawyers Mutual of Kentucky has graciously stepped forward to sponsor the initiative.

The initial phase focuses on unemployment law issues, and the virtual CLE launched on May 1. More than 235 attorneys have already viewed this initial CLE and now have the tools needed to represent Kentuckians facing unemployment law issues. The second phase, which covers housing law issues, launched on July 1st, and it gives volunteers the tools that they need to help Kentuckians who are at risk of losing their housing. We anticipate future phases to include family law and consumer law issues such as bankruptcy and garnishment. The number of individuals needing legal assistance in these areas of law will likely be greater than it ever has been. ## **Robert Joe Turley, Jr.: Passing of an Icon**

In our often hectic existence as attorneys, we tend to overlook those giants of our profession who came before

us. Too bad. So sad. As we honor them, we learn from them. Bob Turley was my law partner for over twenty years, and my dear friend and mentor for over fifty years. He was an icon, defined as a person that is the best example of a profession or some doing something that exemplifies something personifies.

A tireless advocate for those injured or deceased because of negligence, Bob practiced in almost all counties in Central and Eastern Kentucky for most of his adult life. He was recognized as if


not the greatest, one of the greatest trial lawyers of the latter half of the twentieth century. He was the greatest cross-examiner I ever saw. And he never quit. One of his favorite quotes was by Sir Winston Churchill, who famously said:

#### Never give in! Never give in! Never, Never, Never Never – in nothing great or small, large or petty – Never give in except to convictions of honor and good sense.

Bob loved to try cases. He loved to tell stories about them. There was the case where a lady was butted by a buffalo at a zoo, and the case where a horse escaped causing a car crash and the farmer with defective fencing claimed no horses had ever been in that pasture. Bob crossexamined with a picture of that pasture showing a fresh horse turd.

Bob was a great teacher. Early in my career, Bob asked me when in our upcoming trial, we should put

our plaintiff on the stand. I replied with a strategic dissertation on the order of witnesses. "Damn, Joe," he laughed, "you put the plaintiff on first because the rules say so." (No longer the rule). That was the first of many wisdoms that made me and many others better lawyers. Born in 1926, Bob finished Montgomery County High School and then joined the Navy in WW II. He then went directly to UK Law School, where he graduated and was admitted to the Kentucky Bar in 1949 at age 23. He claimed he was the youngest lawyer in Kentucky at that time.



Bob often lectured on the practice of law. He mentored numerous law students and young lawyers. His law partner, Charlie Tackett, and two of his paralegals, Becky Overstreet and Julia Adams, became Circuit Judges. He was a Diplomat of the National Board of Trial Advocacy, a Fellow of the American College of Trial Lawyers, in Who's Who and a recipient of the Henry T. Duncan Memorial Award. Bob served on the KBA ethics hotline for six years. He authored several religious books. He was named the Kentucky Lawyer of the Year in 2001.

Bob was the heart and soul of the Shrine. He was its Chief Counsel and, as a Trustee, helped build hospitals for crippled and burned children all over the United States and Canada. No matter his schedule, he had time to spend countless hours reading to children at our local Shrine Hospital.

Bob was a conservative without apology. We often laughed that while we started from the same selfevident principles of the worth of the individual and the

> equality of all, he was a conservative, and I was a liberal. Bless his heart. He tried to understand my position. He was a realist born of years of trial practice. He understood the foibles of human behavior. He reminded me that no golfer ever marked his ball on the green further away from the cup.

> Bob died on March 15, 2020, leaving a brother, four children, eight grandchildren, nine great-grandchildren, the love of his life, Susan Tebbs, and literally countless judges, lawyers, crippled and burned children, ministers, religious scholars, and friends. His

old Fayette County buddies will now move over and make room for him: Judges Scott Reed, George Barker, Charlie Tackett, Mondo Angelucci, L.T. Grant and lawyers Charlie Landrum, Ben Kessinger, Rufus Lisle, Donald Maloney, Herb Sledd, Bill McCann, and Bill Moore, his law partner for years and others far too numerous to mention. They are all gone now. Let us honor and respect them. They were an endless line of splendor upon which we can dedicate our lives to being better lawyers and people.


