As a member benefit, we are offering 5 free counseling sessions per year to our members. The details of the Program are on the following page. The goal is to offer every member an outlet when they are in crisis or someone to listen and offer counsel in times of need. I encourage you to utilize the program. It is my sincere hope that we can create a safety net for those in crisis and a place to help maintain mental wellness. While we vow to be good stewards of the Association's finances, we believe that if we save one life, it will be well worth any monetary expense.

As my term as President comes to an end, I want to thank each and everyone of you for the privilege of serving you. Although we didn't have a traditional year, to say the least, we worked hard to serve the membership and I am

grateful for resilience and fortitude of each member of the Board and the amazing staff led by our Executive Director, Dana Arnold. The state of our Association is strong and we care about you. The Attorney Wellness Program (AWP)

The Attorney Wellness Program (AWP) was originally designed as a safe harbor for attorneys to address normal life difficulties in a confidential and professional environment.

WHY WAS THIS PROGRAM CREATED?

Being an attorney isn't easy. Difficulties with the current legal and learning delivery systems, maintaining a healthy work/life/family balance, and dealing with the normal stresses of everyday life can take their toll.

We serve many times as counselors to our clients who turn to us for guidance. Who do we turn to when we need to talk through an issue or get some coaching for how to handle stress in our life? Too often the answer is "no one," and that is regrettable because it is imperative that we be as healthy as possible in our role as advocates.

We deserve to function at our best in all areas of our life. By addressing areas of difficulty, we can decrease our stress levels and increase our levels of resilience.

Some examples of those difficulties include:

- Family issues
- Relationship problems
- Grief
- Work-related difficulties
- Alcohol/drug abuse
- Depression and anxiety
- Difficulty managing stress
- Mood swings
- Suicidal thoughts

HOW AWP WORKS

We have contracted our program with The Woodland Group. The Woodland Group will provide counseling to active attorney members of the Fayette County Bar Association. Non-emergency sessions will be scheduled during regular business hours. Emergency sessions can be scheduled on a 24-hour, 7 day-a-week basis.

Seven licensed psychologists make up the Woodland Group and have been vetted by the FCBA. Steven Smith, Ph.D. and Sandra Hough, Ph.D. are our program coordinators and will serve as points of contact to access AWP.

The Woodland Group will maintain a confidential file for each attorney, but no insurance will be billed and FCBA will not be given any information about those who utilize the program. As such, this program is completely confidential which is crucial to its success. FCBA will pay The Woodland Group a monthly bill based on the number of sessions provided. The Woodland Group will verify FCBA membership from the directory on the FCBA webpage.

Pro Bono Program



Wes Deskins, Pro Bono Coordinator, LABG

Hello, FCBA members! My name is Wes Deskins, and I am the new Pro Bono Manager for Legal Aid of the Bluegrass. I am a graduate of the University of Kentucky and the UK College of Law, and I have spent the past 16 years working in various roles at the Kentucky Court of Appeals. I am excited to take on this new

challenge and – with your help – provide civil legal assistance to the thousands of limited-means residents in our area who so desperately need it.

After a difficult year in which LABG was limited in the amount of pro bono opportunities we could provide in 2021, we hope to resume some of our local in-person pro bono services. These include our pro se divorce clinics, where volunteers assist clients in a clinic setting with divorce pleadings, and wills clinics. Volunteers help vulnerable seniors draft wills, living wills, and powers of attorney. These clinics are wonderful opportunities for attorneys to provide needed legal services and, for newer attorneys, to gain subject-matter experience.

We are also reviewing all aspects of LABG's pro bono program and thinking of ways to expand its reach and to provide additional services to the limited-means community – including virtually. We also hope to make the volunteer experience a better one by expanding upon our training and educational materials so that every attorney who needs quality training before taking on a client will receive it. To that end, we look forward to resuming our Legal Aid University courses later this year. These classes provide attorneys with practical information and resources that will give them the skills to provide representation in areas such as domestic violence, expungements, and housing law.

In the meantime, thanks to the Together Lawyers Can pro bono collaboration between Kentucky's legal aid programs, you can sign up for free virtual CLE training designed to enable volunteers to assist Kentuckians in the areas most impacted by the COVID-19 pandemic. If you sign up to be a member of our TLC team at www. togetherlawyerscan.org, you will have immediate access to CLE videos addressing landlord/tenant and unemployment insurance law, and you will be first in line for all future trainings in areas such as family

law and bankruptcy. This year, we anticipate that the number of individuals needing legal assistance in these areas because of the pandemic will be considerable, so the TLC initiative is a great way to utilize your legal skills in a uniquely meaningful way.

We are thankful for all local attorneys who have given so freely of their time and expertise in accepting pro bono clients, but the need for these services continues to be great, and new volunteers are always needed. We currently have a list of eligible clients needing representation in divorce cases, and we hope to connect all of them with a volunteer within the next few months. We are also looking for volunteers willing to help expand our pro bono reach to clients needing help in such areas as bankruptcy, expungements, and probate. Attorneys of all levels of experience are appreciated and welcome, and LABG staff members are always available to help with administrative and substantive questions.

Elizabeth Combs, WLA President


