

What has been the best and hardest part of practicing law for you?

The most rewarding part of practicing law is assisting individuals, who would have no other access to the legal system. I am a staunch advocate for our profession to donate a significant amount of pro bono hours to those people who would normally be shut out from the legal system.

The most difficult part of practicing the law has been the physical stresses the profession and clients place on you. Stress is the silent killer in our profession. I can speak from personal experience that unchecked stress and lack of sleep will have a severely detrimental physical, mental and psychological effect upon yourself, your family, colleagues, practice and friends,

he will practice. Judges have their individual "quirks", expectations and rules of procedure.

Second, socialize and "get involved". Get yourself out to social events and mingle with your colleagues. 


Craig McCloud takes over as President of the Fayette County Bar Association from Steve Stadler.

Henry T. Duncan Award Winner: Pierce Hamblin

Pierce Hamblin graciously accepted the Henry T. Duncan award on Law Day, May 1, 2023. The Fayette County Bar awarded Pierce with their highest honor, which is awarded to an attorney whose integrity and leadership exemplify the high ethical standards of the legal profession.

Elvis once said, "Ambition is a dream with a V8 engine." Whether you know him as the Mayor of Waffle House, The Big Guy, Captain, Teacher or Pierce, you can feel the power of a V8 in his presence. Pierce's ambition was to be an attorney. He insists, "I'm one of those boring fellows who knew what they wanted do from an early age and never wavered from that path." Pierce earned his law degree from the University of Kentucky College of Law in 1977, the year Elvis died. Elvis's untimely death meant Pierce would miss the concert he had looked forward to at Rupp Arena. Of course, Pierce will tell you that Elvis lives, and while I am not sure of that, I am sure the spirit of Elvis lives in Pierce's Elvis room, a shrine built

next to his office that houses an assortment of Elvis memorabilia. The room has come to be known as a "come to Jesus" room for Pierce and his mediation clients.

On March 15, Pierce celebrated his 45th anniversary with Landrum & Shouse LLP, where he is a partner. Pierce was a defense attorney known primarily for his work on insurance cases, until 2006, when he took a chance and began focusing on the growing field of mediation and arbitration. It was a chance that paid off, as Pierce has gained recognition as one of Kentucky's most respected mediators. He has been a member of the National Academy of Distinguished Neutrals since 2010. Pierce has relied on his experience as a defense attorney, as he notes, "I think having been a defense attorney makes you a better mediator. Because you really have to evaluate your cases as a defense attorney. You've got to look at both sides, at the strengths and weaknesses; you just can't take for granted everything you're told. It's helped me learn to listen to both sides."

Aside from his experience as a defense attorney, his wit, charm and overall love of people have contributed to his successes. Most every morning Pierce can be found eating breakfast at the Hamburg Waffle House and has earned the title Mayor of Waffle House. Members of the staff consider him family and enjoy his jolly humor daily. If you do decide to check out the place, Pierce stresses that if you say he sent you, "You all better learn how to properly order your hashbrowns. As mayor of Waffle House, I don't want to be embarrassed." In addition to serving Kentucky as an attorney, Pierce was an adjunct professor of law at the University Kentucky College of Law. For over 40 years, he taught a course in trial work and trial tactics known as Litigation Skills and a course known as Negotiations to senior law students. Never short on humor, Pierce described his litigation skills class, "like watching a combination of Duck Dynasty and the Real Housewives of Las Vegas." In all seriousness, Pierce cherished his time working with the students, as he emphasized, "One of my greatest passions in life has been teaching at the UK College of Law. I think it's important to teach my students to be good lawyers, but it's more important to teach them to be good people." As demonstrated by the number of hands raised when Pierce asked the audience at Law Day who had attended his classes, it is easy to see the impact he has made. A former student once said, "It's impossible to imagine where all of us would be today if we hadn't had Pierce there teaching us, helping us, cheering us on and guiding us in our lives and careers. We are all better for having known Pierce."

Pierce proudly served his country as a Captain in the United States Army and Army Reserves. He specialized as a tactical intelligence officer, analyzing and predicting Soviet military moves in the final days of the Cold War. He was The Distinguished Graduate of the Military Intelligence Officer Basic Course provided by the Army for 1977, and he is certified both as a Tactical Intelligence Officer and a Counter-Intelligence Officer. He earned a degree in Military Law from the University of Virginia College of Law. Thereafter, he served as the Judge Advocate for an Army Training Brigade.

As a great community service ambassador, Pierce acts as a mentor for every law school in the Commonwealth for students participating in the Kentucky Legal Education Opportunities (KLEO) Programs. He has served in this program since its inception. This program

provides guidance for entering law students from underrepresented and diverse areas of the state.

The spirit of the Henry T. Duncan Award has been demonstrated in all aspects of Pierce Hamblin's life. The award will join a prestigious list of recognitions that include:

- The Service to Young Lawyers Award KBA Young Lawyers Division, 2013
- National Academy of Distinguished Neutrals (Charter Member from Kentucky), inducted 2010

- Distinguished Lawyer of the Year Award for the Commonwealth of Kentucky by the KBA, 2017
- Recognized as a Top 50 Kentucky Super Lawyers, 2007-2022
- Recognized as a Top 10 Kentucky Super Lawyers, 2012-20
- Best Lawyers, Lawyer of the Year Mediation, Lexington, KY. - 2014 & 2016 & 2020 & 2022

Pierce served as a member of the Board of Directors for the Kentucky Bar Foundation of the Kentucky Bar Association and was the president of the Fayette County Bar Association for the year 2014. Additionally, he served as an auditor for the Fayette County Bar Association and an officer, serving as secretary and vice president.

Pierce's most vital roles are husband and father. He coached soccer, baseball and basketball in the youth leagues of Lexington. His love for his family is on display in his office, where you will find an abundance of photos. It is not recommended to ask him why he has so many photos, as he asserts, "People say to me, 'Pierce, why do you have so many pictures of your kids on your wall?' You know what I tell them? I tell them, you can kiss my ass!"

If you are wondering if Pierce Hamblin has any intention of slowing down, the answer is no. He reminds us, "A lot of people work hard-I don't want to be seen as a martyr. I'm never going to retire. My work is my hobby-I think when you retire, you sign your death warrant. My dad didn't retire; I'm not going to retire."

The Attorney Wellness Program (AWP)

The Attorney Wellness Program (AWP) was designed as a safe harbor for attorneys to address normal life difficulties in a confidential and professional environment.

WHY WAS THIS PROGRAM CREATED?

Being an attorney isn't easy. Difficulties with the current legal and learning delivery systems, maintaining a healthy work/life/family balance, and dealing with the normal stresses of everyday life can take their toll.

We serve many times as counselors to our clients who turn to us for guidance. Who do we turn to when we need to talk through an issue or get some coaching for how to handle stress in our life? Too often the answer is "no one," and that is regrettable because it is imperative that we be as healthy as possible in our role as advocates.

We deserve to function at our best in all areas of our life. By addressing areas of difficulty, we can decrease our stress levels and increase our levels of resilience.

Some examples of those difficulties include:

- Family issues
- Relationship problems
- Grief
- Work-related difficulties
- Alcohol/drug abuse
- Depression and anxiety
- Difficulty managing stress

HOW AWP WORKS

We have contracted our program with The Woodland Group. The Woodland Group will provide counseling to active attorney members of the Fayette County Bar Association. Non-emergency sessions will be scheduled during regular business hours. Emergency sessions can be scheduled on a 24-hour, 7 day-a-week basis.

Seven licensed psychologists make up the Woodland Group and have been vetted by the FCBA. Steven Smith, Ph.D. and Sandra Hough, Ph.D. are our program coordinators and will serve as points of contact to access AWP.

The Woodland Group will maintain a confidential file for each attorney, but no insurance will be billed and FCBA will not be given any information about those who utilize the program. As such, this program is completely confidential which is crucial to its success. FCBA will pay The Woodland Group a monthly bill based on the number of sessions provided. The Woodland Group will verify FCBA membership from the directory on the FCBA webpage.

Legal Help Center in Fayette County offers legal information, forms and guided interviews

The Fayette County Legal Help Center, which opened to the public in March 2022, has now assisted more than 1000 self-represented litigants. The Center offers information on a variety of legal topics, including divorce, expungement, child support and simple probate matters.

The Legal Help Center is the result of a collaboration between the Kentucky Access to Justice Commission (KAJC), the Fayette County Office of the Circuit Court Clerk, the Fayette County Family Court Judges, the Fayette County Law Library Trustees, the Administrative Office of the Courts and Legal Aid of the Bluegrass. The Center is open every Thursday from 11 a.m. - 2 p.m. and is located in the Law Library, Room CB02A of the Robert F. Stephens Circuit Courthouse, 120 N. Limestone, Lexington. There is no charge for the information and assistance provided.

How Legal Help Center Works

The first of its kind in Kentucky, and modeled after those already established in other states, the Center is staffed with KAJC staff, volunteer lawyers and trained volunteers. Patrons walk in and are assisted on a firstcome, first-serve basis. They are asked to briefly describe their legal issue and are then assisted by a volunteer.

While volunteers do not provide legal advice, they do offer legal information, which includes helping patrons locate and complete the legal forms appropriate to their legal issue. Many of the forms that patrons need can be completed through guided interviews. The guided interviews are user-friendly, with the patron simply answering a series of questions. Once the interview is complete, the program generates the required court documents.

Some of the guided interviews available to patrons are:

- Petition for dissolution of marriage (no minor children)
- Petition for name change
- Small Claims Petition and Counterclaim
- Petition for Expungement (For Misdemeanor, Violation, or Traffic Infraction Conviction)
- Petition/Order to Dispense with Administration (Surviving Spouse/Children/Preferred Creditor)
- Petition for Probate of Will; and/or Appointment of Executor/Administrator

- Petition/Motion for Order of Protection
- Motion to Modify Child Support
- Financial Statement, Affidavit of Indigency, Request for Counsel and Order (Criminal Case)
- Motion for Waiver of Costs and Fees and to Proceed In Forma Pauperis; Affidavit; Financial Statement

KAJC and Kentucky's four civil legal aid programs launched another self-help legal resource in March 2022 when the updated website, kyjustice.org, went live. The site provides information on various civil legal topics, including family law matters, criminal expungement, housing and consumer issues. It also offers answers to common legal questions, a tool that screens for legal aid eligibility and an interactive county-by-county resource




