Dear Members of the Awards Committee,

It is my privilege to nominate Kevin G. Henry for the Henry T. Duncan Award. Kevin's 46 years of experience in civil litigation, his unwavering integrity, leadership, and professional conduct, his leadership in the Fayette County Bar Association, and his outstanding contributions to the community make him an exemplary candidate for this prestigious award.

Kevin's extensive legal career has concentrated on financial and fiduciary litigation. He has done precedent setting work on governmental immunity, successfully defending the City of Frankfort and its planning staff, as well as the Lexington-Fayette Urban County Airport Board, in important published cases that clarified the governmental immunity of municipal planning and sewer functions, and county boards and affiliated corporations.

He represented creditors in several prominent bankruptcy cases such as the Calumet Farm Trophy litigation, the Lew Perrin McGee Ponzi scheme bankruptcy, the Zayat Stables Chapter 11 case, the Pacer Health Management bankruptcy (Knox County Hospital), and many coal company cases, and obtained critical vendor settlements in major Chapter 11 cases in New York, Virginia, and Kentucky. He has represented beneficiaries of several of the largest trusts in Lexington for over 20 years through multiple rounds of litigation. He advised a Division I university athletics department on the largest multimedia-rights contract of its kind at the time and successfully defended antitrust litigation concerning Division I intercollegiate sports and simulcast wagering on horse racing.

Kevin's trial and appellate cases have spanned a wide range of issues, including banking, bankruptcy, will contests, trust mismanagement, contracts, director and officer liability, class action defense, shareholder disputes, equine disputes, securities fraud, lawyer and accountant malpractice, and insurance coverage disputes. His dedication to his clients and his thorough approach to each case have earned him a reputation as a trusted and effective advocate.

One notable example of Kevin's dedication is his work in a case against the FDIC, where he spent days in a freezing unheated warehouse searching for documents to prove dishonest conduct. His commitment to the community extends beyond his legal practice. Kevin believes in supporting the next generations of both the legal community and his community at large.
